The Wellesley Board of Public Works held a duly posted open meeting in the Boardroom of the DPW Operations Building, 20 Municipal Way, convening at 5:15 p.m.

CITIZEN SPEAK

The Chairman provided those in attendance with the opportunity to speak regarding matters pertaining to the Department of Public Works. No one chose to speak.

PARK & HIGHWAY DIVISION

Statement of Fact – Contract #19S-420-1623 for Hot Mix Asphalt, Picked-Up.

Director Cohen explained to the Board that it would be necessary to vote to rescind the initial award made at the April 11, 2019 Board of Public Works meeting due to an error. The contract specification was written such that each ITEM is to be considered separately and each ITEM is to be awarded to the lowest qualified bidder.

Following a discussion and upon motion duly made by Mr. Donohue and seconded by Mr. Wechsler, it was unanimously,

VOTED: To rescind the award for Contract #19S-420-1623 for Hot Mix Asphalt, Picked-Up made at the April 11, 2019 Board of Public Works Meeting, which awarded both Bid Items I and II, in error, to Lorusso Corporation, 3 Belcher Street, Plainville, MA 02762.

Upon motion duly made by Mr. Donohue and seconded by Mr. Wechsler, it was unanimously,

VOTED: To re-award Contract #19S-420-1623 for Hot Mix Asphalt, Picked-Up to the lowest responsible and responsive bidder, Lorusso Corporation, 3 Belcher Street, Plainville, MA 02762, for Item I and that the lowest responsible and responsive bidder, Mario Susi & Son, Inc., 36 Westwood Street, Dorchester, MA 02121, for Item II in accordance with our specifications and their bid prices as follows:

Following a brief discussion and upon motion duly made by Donohue and seconded Mr. Wechsler, it was unanimously,

VOTED: That Contract #19C-420-1625 for Road Restoration – Hot Mix Asphalt, In-Place, Cold Planing & HMA Berm be awarded to the lowest bidder, Lorusso Corporation, Plainville, MA in accordance with our specifications and their bid prices as follows:

Item I: Furnish, deliver, spread and compact to grade. \$72.45/Ton
Hot Mix Asphalt, Class I Type I Top or Binder.

Item II: Furnish, deliver, spread and compact to grade. \$85.06/Ton
Hot Mix Asphalt, Class I Type I Top or Binder
(Night hours)

Item III: Cold Plane and/or Profile Hot Mix Asphalt Surfaces \$2.15/SY
to a depth of up to 2” inches.

Item IV: Cold Plane and/or Profile Hot Mix Asphalt Surfaces \$5.75/SY
to a depth of up to 2” inches.
(Night hours)

Item V: Install HMA Berm, MassDOT Type 2. \$4.00/LF


ADJOURNMENT
