

WELLESLEY BOARD OF PUBLIC WORKS RECORDS
August 8, 2019

The Wellesley Board of Public Works held a duly posted open meeting in the Boardroom of the DPW Operations Building, 20 Municipal Way, convening at 11:00 a.m.

PRESENT

Those present included Commissioners Ellen Korpi and Jeffrey P. Wechsler; Director of Public Works David A. Cohen; Assistant Director of Public Works Jeffrey Azano-Brown; Assistant Water & Sewer Superintendent Meghan Condon and Executive Secretary Debra Surner.

CITIZEN SPEAK

Ms. Korpi called the meeting to order and provided those in attendance with the opportunity to speak regarding matters pertaining to the Department of Public Works. No one chose to speak.

WATER & SEWER DIVISION

Irrigation Well Request – 892 Washington Street Wellesley, Massachusetts.

Ms. Condon conveyed to Ms. Korpi and Mr. Wechsler that she has been in contact with Leonard Izzo, the Director of the Wellesley Health Department and confirmed that he has no objection to this request for a private irrigation well. Ms. Condon also notified the Board that the main issue is to reconfirm there will be no cross connection of well to the public water system. Another requirement is that the well have no impact on the buffer zone.

Mr. Cohen noted that the Board of Public Works granted authority to the Director of Public Works to approve geothermal wells in 2011. Since these wells are closed-loop geothermal wells, they will not pump water and will function as a geothermal source for heat exchange purposes. There is no potential for water cross-connection. However, since irrigation wells tap into the aquifer, those requests do require approval by the Board of Public Works.

Upon motion duly made by Mr. Wechsler and seconded by Ms. Korpi, it was unanimously,

VOTED: To approve the petition and request for a private irrigation at 892 Washington Street, Wellesley, MA as described in Assistant Water & Sewer Superintendent Condon's Recommendation of Approval dated July 30, 2019. (Copy attached.)


ADJOURNMENT
