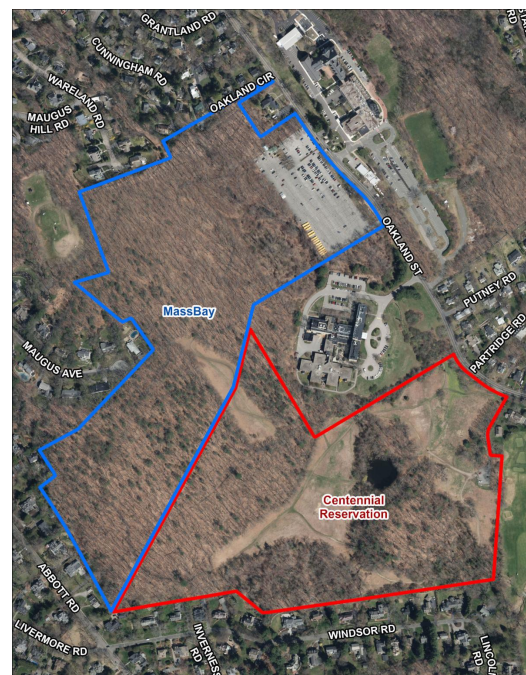

### MassBay Development Proposal

The Select Board and Planning Board have heard from many residents about a proposal by MassBay Community College (50 Oakland Street) to build a new Cybersecurity, Health, and Wellness Center and sell 45-acres of undeveloped land across the street, including the current student parking lot, to the State Division of Capital Asset Management and Maintenance (DCAMM) for housing development.

This proposal is coming forward under the [Massachusetts Affordable Homes Act of 2024](#) which helps address housing challenges in the Commonwealth and prohibits cities and towns from imposing restrictions on the development of housing. Under this proposal, the State would buy the land and will consider proposals to build housing at a minimum density of four units per acre.

## Climate Action Committee Takes Action

The [Wellesley Climate Action Committee](#) recently took the unusual step in expressing strong opposition to a U.S. Environmental Protection Agency (EPA) proposal. The committee voiced its support for preserving the [Endangerment Finding](#), which concluded that greenhouse gas emissions are a danger to public health and welfare. This finding provided the EPA the authority to set and enforce regulations to limit emissions but is currently proposed for removal. Wellesley's [Climate Action Plan](#) is built around these existing standards.

### Skip the Stuff in 2026

Beginning in January 2026, all food service establishments in Wellesley will provide single-use items **ONLY** by customer request or at a self-service counter.

This new Board of Health bylaw, known as [Skip the Stuff](#), was passed by 2025 Annual Town Meeting and is intended to: 1) Reduce the amount of waste generated by single-use articles, 2) Change customer habits, 3) Help reduce unnecessary costs to food service establishments. Single-use food ware is a huge and growing portion of the waste stream entering landfills and incinerators, and polluting city streets and waterways.

We appreciate the cooperation from all of our food service establishments who will be asking customers if they want utensils or condiments. Watch for much more information on "Skip the Stuff" in the coming months from the Health Department, the Climate Action Committee, and the RDF.

## Please! Mind Your Manners at the RDF

Recycling and Disposal Facility (RDF) staff is reminding users to do their part to be safe, efficient, and respectful when visiting. A few tips:

- Listen to Staff - Employees are available to keep things running smoothly and offer help when needed.
- Be Kind - Please be patient and understanding, especially at busy times.
- Drive Safely & Slowly - Be careful, watch out for other cars, equipment, and pedestrians.

- Unload Smart - Place items in the correct locations. Personal items (keys, wallets, phones) should remain in your car, not in the bins! Use care with heavy or sharp materials.
- Practice Courteous Behavior - Reckless driving, arguing with staff, or incorrect dumping is risky and may result in a loss of RDF privileges according to Board of Public Works regulations.

## Hydrant Flushing Begins October 20

The **DPW Water and Sewer Division** will flush water mains from Monday, October 20 through Friday, October 24 between 8 a.m.- 5 p.m. This annual activity removes sediment buildup in the mains and makes sure fire hydrants and valves are working correctly. Flushing may temporarily discolor water due to small particles dislodged during the flushing, and may also briefly reduce water pressure. Discolored water is not harmful but may stain laundry.
