Campaign finance for town wide candidates.

See new tutorial below offered by the Office of Campaign and Political Finance.

- If you choose to solicit donations from anyone else to fund your campaign you must form a campaign finance committee with an independent treasurer – use M 102 to report income and expenditures (four campaigns have filed committee formation documents)
- If you spend your own funds you do not need a committee, but must file reports on expenditures. Use form M102 attached
- If you neither collect nor spend anything on the campaign you must file a disclosure – Use form m 1020 attached.

### Filing deadlines

8 days prior report for all candidates – Reporting period date of committee organization or filing of nomination papers - February 17;

filed February 27 ( all candidates – see form above)

30 days after report for all candidates - filing period February 17- March 27;

filed by April 6 (all candidates- see form above)

If you have a committee and have expended all funds (no balance) by the 30 days after report you can also dissolve at that point.
