Petition of Wellesley Place LLC
978 Worcester Street (MGB)

Pursuant to due notice, the Special Permit Granting Authority held a Public Hearing on Thursday, December 1, 2022, at 7:30 p.m. in the Juliani Room, 525 Washington Street, Wellesley, on the petition of Wellesley Place LLC requesting a Special Permit pursuant to the provisions of Section 5.18 and Section 6.3 of the Zoning Bylaw for replacement of existing signs that will exceed the number of signs allowed by right and for installation of a wall sign with a logo height that will exceed the maximum height allowed by right and set at height that exceeds that height allowed by right in a commercial district fronting Worcester Street, at 978 Worcester Street, in a Business A District.

On November 1, 2022, the Petitioner filed a request for a hearing before this Authority, and thereafter, due notice of the hearing was given by mailing and publication.

Present at the public hearing was Jason Bridges, Design Communications Ltd., representing Mass General Brigham (MGB), who said that they are in the midst of rebranding across Massachusetts. He said that 978 Worcester Street is one of their two locations are in Wellesley.

Mr. Bridges said that the sign proposal received conditional approval from the Design Review Board (DRB). He said that the request is to exceed the number of signs allowed by right. He said that they would like to add an Orthopedic Walk In sign on the lower front elevation to identify the location of a facility where patients are seen, not by appointment exclusively. He said that the DRB had concerns about appropriate wording for the sign. He said that after speaking with the doctors for Newton-Wellesley, they felt that it was appropriate for the orthopedic walk-in facility. He said that the facility will be available to treat minor sports injuries.

A Board member said that he agreed with the Planning Board's concern about the amount of signage. He said that there will be a replacement main sign at the top of the entrance, a new sign for the walk-in facility, and replacement vinyl signage on the doors. He asked if the walk-in sign could go on the standing sign instead. Mr. Bridges said that the hope was to differentiate the walk-in area from the rest of the clinic and call attention to a service that is available. A Board member confirmed that there is a separate entry to the walk-in.

There was no one present at the Public Hearing who wished to speak to the petition.

Statement of Facts

The subject property is located at 978 Worcester Street, in a Business A District.

The Petitioner is requesting a Special Permit pursuant to the provisions of Section 5.18 and Section 6.3 of the Zoning Bylaw for replacement of existing signs that will exceed the number of signs allowed by right and for installation of a wall sign with a logo height that will exceed the maximum height allowed by right and set at height that exceeds that height allowed by right in a commercial district fronting Worcester Street.

Letter of Authorization, dated 6/22/22, signed by Michael Carr, Wellesley Place LLC Building Owner, Sign Information, Town of Wellesley Building Department Sign Application, dated 10/12/22, Plans Version 4, dated 2/23/22, Site Map, E-01A, E-01B, E-02A, E-02B, E-03, E-04A, E-04B, prepared by BrandActive, Sign Type Custom DL.C.30" Color Dimensional Letters and Sign Type DM.C.8 Color Dimensional Messaging, dated 4/5/22, revised 6/7/22, prepared by DCL, were submitted.

On October 19, 2022, the Design Review Board reviewed the signs and voted unanimously to recommend approval of the wall sign, subject to recommendations

On November 16, 2022, the Planning Board reviewed the petition and recommended that a special permit be approved.

Decision

This Authority has made a careful study of the materials submitted and the information presented at the hearing.

It is the opinion of this Authority that replacement of existing signs that will exceed the number of signs allowed by right and for installation of a wall sign with a logo height that will exceed the maximum height allowed by right and set at height that exceeds that height allowed by right in a commercial district fronting Worcester Street will be in harmony with the general purpose and intent of Section 5.18 of the Zoning Bylaw, as the sign scale will be in reasonable relation to development scale, viewer distance and travel speed, and sign sizes on nearby structures; sign size, shape, and placement will serve to define or enhance architectural elements of the building and will not unreasonably interrupt, obscure or hide them; sign design will be in reasonable continuity with the mounting location, height, proportions and materials of other signage on the same or adjacent structures; sign materials, colors, lettering style, illumination and form are reasonably compatible with building design, neighborhood context and use; and sign size, location design and illumination are not judged to present a safety hazard to vehicular or pedestrian traffic.

Therefore, a Special Permit is granted for replacement of three (3) window signs, two (2) wall signs, one (1) standing sign, and for installation of a wall sign set at a height of 30.7 feet, with a 2 foot 6 inch logo, in accordance with the submitted plans.

The Inspector of Buildings is hereby authorized to issue a permit for the sign upon receipt and approval of a sign application and any other materials he may require. No sign shall be installed until said permit has been issued.




