Shawn Baker returns to Advisory after serving as a Committee member, Secretary and Chair during his 2020 to 2023 appointment. Shawn is a Town Meeting Member representing Precinct F. Shawn is an attorney who retired as a principal after 32 years with PwC. Shawn advised financial services clients on a variety of topics including product structure, mergers and complex financial instruments. Shawn led PwC's national mutual funds tax practice for 25 years. Shawn is a member of the American Bar Association's Sections on Business Law, and Taxation. He served as Chair and Vice Chair of the Tax Section's Committee on Investment Management.
